Over the years, it has introduced innovative solutions to the market, such as accessories for bituminous and PVC waterproofing systems, as well as height-adjustable support systems for raised floors. In 2001, the company relocated to its current headquarters in Ceggia (VE), continuing its expansion both in the Italian and international markets.
